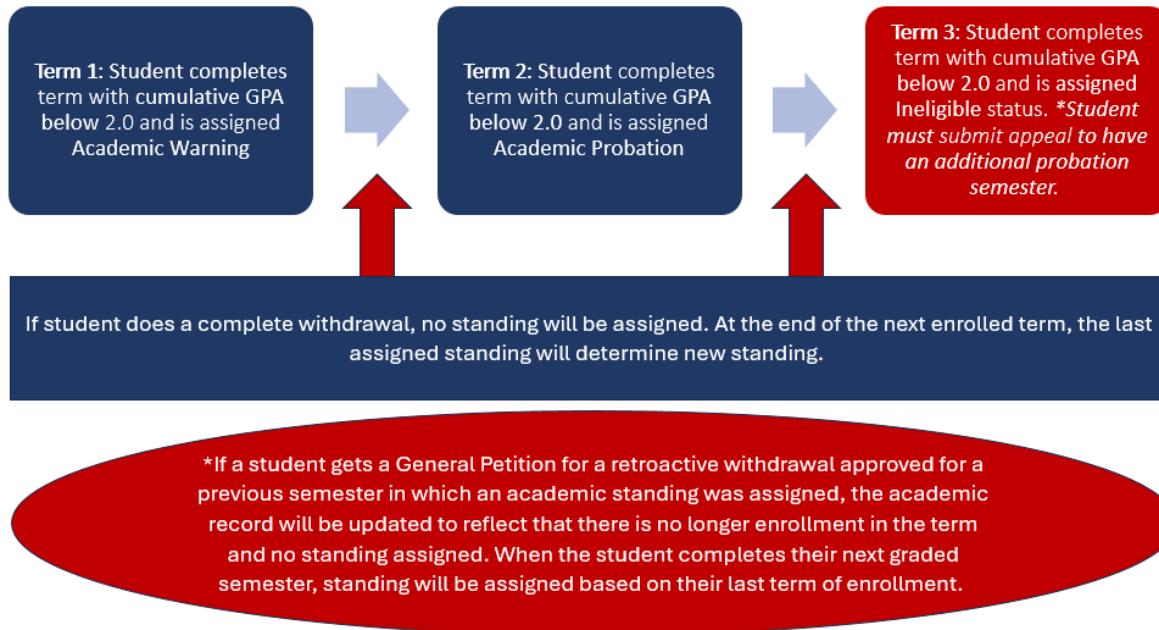

How academic eligibility is assigned

The Undergraduate Academic Eligibility Policy is designed to help undergraduates stay on track for degree completion at the University of Arizona and is calculated for all undergraduate students completing graded units at the end of each fall and spring term.



Academic Eligibility Interventions- Spring 2025

Students are required to participate in an intervention to help them achieve a 2.0 cumulative GPA and Eligible standing. All students will be required to take a self-assessment (more information in the next section) to align their needs with available resources. Support offices will document their interactions with students in Trellis.

ACADEMIC WARNING INTERVENTION STUDENT PROCESS

- Student Assigned Academic Warning (ADW) in Fall 2024
- Email communication from the Office of the Registrar which includes link to self-assessment
- Student takes self-assessment
- Receives follow up from college assigned intervention

In the **academic warning** semester colleges/academic programs determine the intervention that will best support their students. Please contact the advising lead for

your area if you have any questions about your college or department specific messages to students as well as the required intervention in the warning semester.

ACADEMIC PROBATION INTERVENTION STUDENT PROCESS

- Student Assigned Academic Probation (ADP) in Fall 2024
- Email communication from the Office of the Registrar which includes link to self-assessment
- Student takes self-assessment
- Receives follow up from selected resource

In the **academic probation** semester Student Success & Retention Innovation along with campus partners use the self-assessment resource selected by the student to assign the intervention that will best support each student.

****All Arizona Online students in the Academic Probation semester regardless of survey response will be assigned a Success Coach to help determine the best resources for that student within the Arizona Online network.***

****All C.A.T.S. and SALT students in the Academic Probation semester regardless of survey response, will work with that office to receive support.***



Viewing Academic Probation Intervention Information

Once students submit their self-assessment form, they will be added to the academic probation intervention program group within Trellis utilizing the new Program Management tool called “Opportunities”. Individual groups (except for those receiving services from SALT and CAPS) will document their interactions within Trellis.

Students who have completed the self-assessment and are being supported by one of the groups listed above will have “Spring 2025 SSRI Academic Probation Support” listed as an Opportunity in the Related tab of a student record.

Self-Assessment

Academic Eligibility Self-Assessment

Students receive email notification of academic standing at the end of their fall and spring graded semesters where they are enrolled at the university and have earned grades in courses. Within the standing assignment email, students on **Academic Warning or Academic Probation** will be told that their next steps are to take the [self-assessment](#) and connect with their academic advisor. The deadline for spring interventions is **Friday January 31st**.

To connect students with the right support, students will be asked to complete the self-assessment. The link will be part of the assigned eligibility standing message; students can also find the link in the Forms section of Modern Student Center.

Planning Tools to Support Students

There are many tools to help your students create goals in their academic warning and academic probation semesters to improve their GPA. Please work with your academic advising lead to understand how these tools can best be used.

Academic Success Plans

Academic Success Plans (ASP's) are available in UAccess where academic units can provide specific academic goals/requirements students must meet in order to continue with their current major.

Trellis Personal Program Plans

Plans allow you to help students maximize their time at the University by creating a roadmap to accomplish goals that may or may not be listed in their Academic Success Plan.

CatCloud is where students access their plans, plan notes, and associated files. Plan items are broken down by term and due dates. Trellis users can utilize pre-formatted templates, clone existing plans, or create their own plans to best cater to the unique needs of the students they support. These individualized plans can be shared with advisors and other university staff.

Returning Student Policies

Students will need to [reapply](#) to the university if:

- They are assigned academic probation status and take the next major semester off.
- They become Ineligible and do not submit an appeal.
- They become Ineligible and the submitted appeal is denied.

BACK2UA

Students who left the University of Arizona and qualify for [Back2UA](#) (left with a status of Eligible, Academic Review, or Academic Warning) can return without re-applying for admission. To see when you are eligible to return through [Back2UA](#), view the [table online](#).

Second Start

Undergraduates seeking readmission to The University of Arizona after an absence of at least three years may apply for the [Second Start Readmission Program](#). When a returning student applies for readmission through Second Start, the student's application and prior academic record are reviewed by the academic college offering the student's program of study. If accepted by the college and the University, students are also accepted into the [Second Start Program](#).

Once the conditions of Second Start are met, all grades earned for UA course work prior to the student's absence will be disregarded in the student's cumulative GPA; however, courses in which a C or better was earned will continue to fulfill degree requirements. Credit for those courses with a C grade or above will count as earned units toward specific requirements (e.g., General Education, the major or minor), class standing, and total degree units. But only the courses taken **after** Second Start is enacted will count toward the [University Credit](#) requirements.

Academic Renewal

Academic Renewal allows students to have grades for a particular period of time excluded from the grade-point-average (GPA). If the qualifications are met, the student may have a maximum of four consecutive semesters of course work disregarded in all calculations regarding academic standing, grade-point-average, and eligibility for graduation. Academic Renewal provides an excellent opportunity recover from a poor academic history. However, students do lose credit for any courses passed during semesters in which Academic Renewal is applied. Students should work closely with their advisors to see if they qualify to use this tool and whether its benefits outweigh the costs.

Academic Renewal may be effected only once during a student's undergraduate academic career and is not available to students who have completed requirements for a bachelor's degree.

Academic Ineligibility Appeals Process

ACADEMIC INELIGIBILITY AND THE APPEALS PROCESS

Students who become Ineligible after the Fall 2024 term must [appeal](#) to be eligible to remain or enroll in classes at the University. Students whose appeals are approved will be granted an additional term of Academic Probation. Students can submit appeals before standing has run for the term, but no appeals will be reviewed until after final grades are posted and Ineligible status is calculated for a student in a term. All appeal decisions are final.

What are the appeal form questions?

There are three open sections in the form that ask students to:

- 1) Reflect on the circumstances that impacted their academic performance
- 2) Reflect on the resources that they used in the most recent semester
- 3) Describe their plan to get back to eligible status

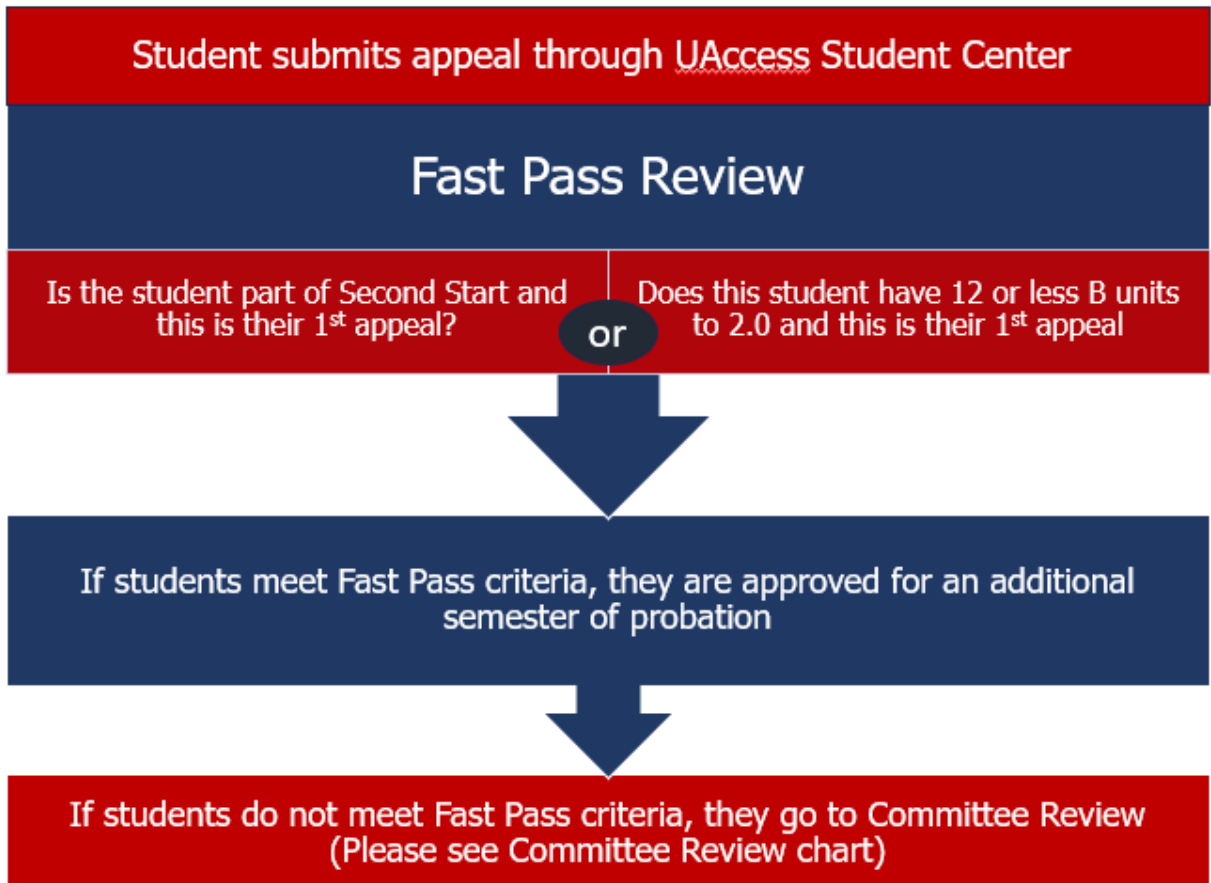

How are appeals reviewed?





Please Note:

Appeals are randomly assigned to the academic advisors who are part of the Appeals Review Committee.

The Core Review is conducted by one of three Advising Directors assigned to the Academic Eligibility Core Team, and who make those final decisions in case of a tie or where both reviewers do not recommend another semester of Academic Probation.

What do reviewers look for in an appeal?

Academic Eligibility Appeal Review Guidelines- Fall 2024

Students who become Academically Ineligible at the end of a given semester can appeal that decision and be granted an additional semester of academic probation to raise their GPA to a 2.0 and move back to Eligible status. Academic Advisors are randomly assigned student appeals to review holistically to either approve or deny the student an additional semester of academic probation. Students are reviewed holistically; the two major components of the appeal are the student's written appeal with narrative, and their academic profile. Both components are weighted equally in the decision.

The **Academic Profile** considers the following items: student engagement with their advisor, the units of B to 2.0, GRO and W opportunities still available, and the trend of the student's GPA. The

question being asked is “can this student make it back to Eligible status in 1-2 semesters based on their current academic profile?”. Whether the student can achieve the 2.0 for graduation is also a consideration.

The **Academic Eligibility Appeal** submission is reviewed for full and complete responses to each question that provide necessary information in a clear and concise manner. Most importantly, reviewers should ask whether there is evidence of resource and intervention participation in the last semester to support the student’s academic efforts? Does the student have a clear, actionable, and achievable plan for getting back to Eligible status?

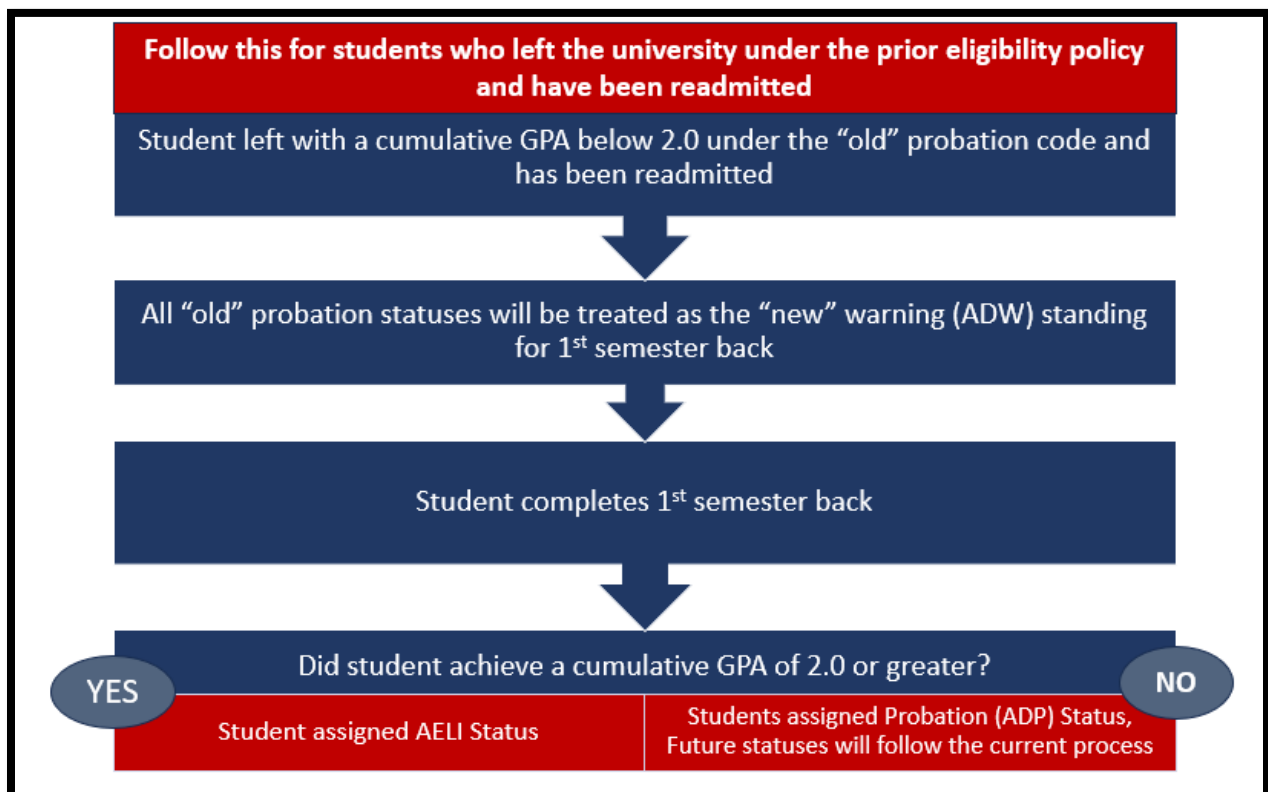

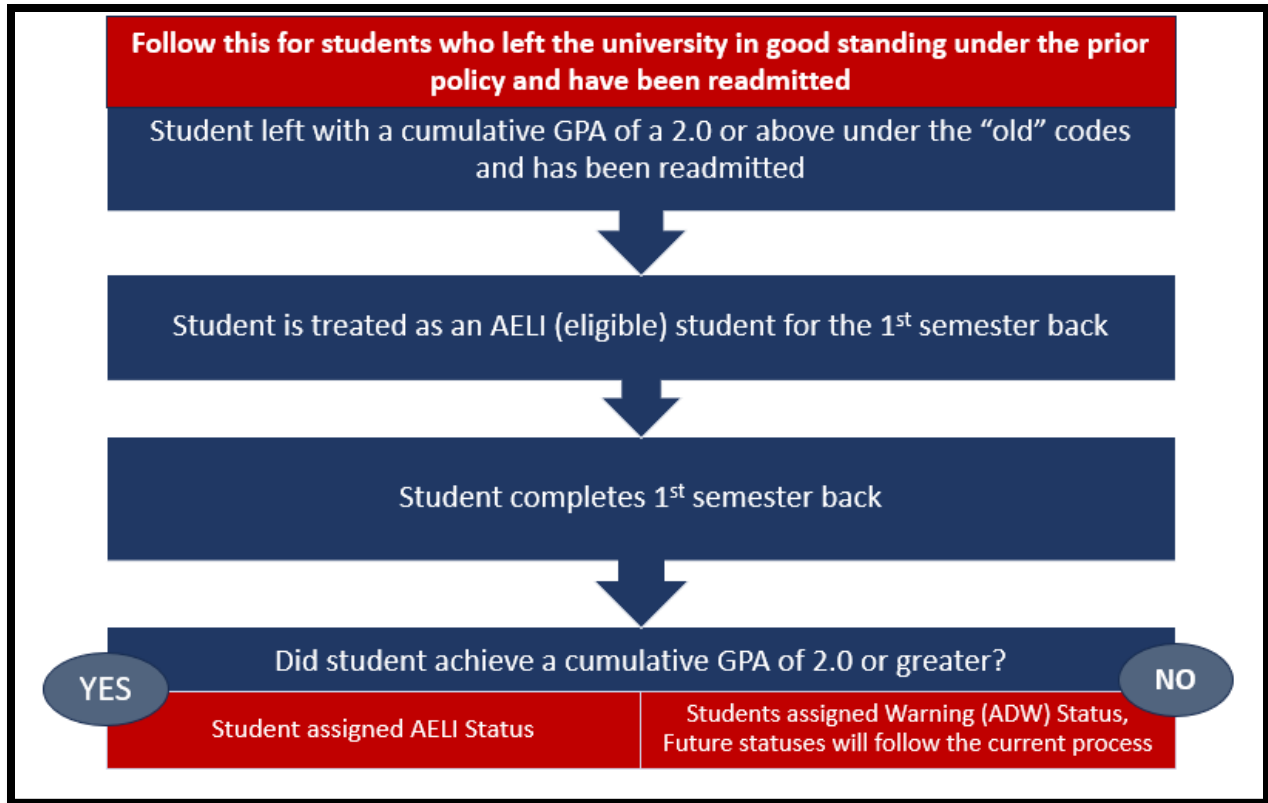
What happens if my student doesn't appeal or has an appeal denied?

- In both scenarios, the student will be dropped from any Spring 2025 enrollments, as well as any summer coursework in sessions that have not started at the time of decision. Drops will occur prior to the first day of class to avoid incorrect billing.
- Students may appeal their eligibility for a given term only once; **there are no appeals of the appeal committee's decision.** All students receive an email with their appeal decision to their university account.
- Students who have an appeal denied will be discontinued and may choose to re-apply to the university for a future term. *Readmission is not guaranteed.*

My student was readmitted to the university. In their last term of enrollment, they were assigned a code that is no longer used to reflect eligibility. What happens now?

- If a student is readmitted with one of the "old" codes (those used prior to Fall 2019), please see the charts below to understand what will happen after their first graded semester back.

The University of Arizona supports student mental health through a variety of services and tools. From virtual on-demand mental health options, free resources, and workshops to counseling, survivor support, and short-term medication management, there are many paths to supporting your mental health. Strengths Coaching

Strengths Coaching includes meetings with a professional staff member from your academic unit or the Thrive Center Outreach & Advocacy team. These meetings will focus on exploring and building up your strengths, and you will receive support navigating the institution (barriers, policies, and procedures), setting goals, and exploring your identity.

Peer Mentoring

Peer Mentoring includes meetings with a student mentor from your academic unit or the Thrive Center. You will be assigned a mentor based on your needs or shared identities (e.g., major, first-gen, transfer, etc.). Peer Mentoring will provide you with an accountability partner, and you will receive support navigating college, processing life, and building community.

Academic Skill Building

Academic Skill Building includes personalized one-on-one meetings with an Academic Coach in your academic unit or at THINK TANK. As learning science experts, Academic Coaches help you achieve your goals and academic potential. In these meetings, you will strengthen your academic skillset (including study skills, learning strategies, and time management) and build habits of self-reflection and well-being. In addition, we can connect you to tutoring and writing support.

ACADEMIC ELIGIBILITY POLICY OVERVIEW

Academic eligibility is the ability to enroll in courses at the University of Arizona; it is automatically calculated at the end of each fall and spring semester. The policy is designed to help undergraduates stay on track for degree completion at the University of Arizona.

There are five (5) academic statuses related to a student's eligibility to enroll in courses.

Eligible

- All new undergraduate students begin with a status of Eligible (i.e., good academic standing);
- Students must earn and maintain a 2.00 or higher cumulative GPA to continue in Eligible status;
- Students with a status of Eligible may enroll in courses.

Academic Review

- Review status occurs when a student earns a cumulative GPA of 2.00 or above (i.e., good academic standing), but has a semester GPA of less than a 2.00.
- Students with a status of Academic Review will be contacted by their college or school to determine if they need assistance to improve their GPA.

Academic Warning

- Warning status occurs when an undergraduate who was previously Eligible does not earn a 2.00 or higher cumulative GPA;
- Students with a status of Academic Warning may enroll in courses; however, they will be contacted by their college or school and required to complete an intervention;

- Students who begin a semester/term with a status of Academic Warning and earn a cumulative GPA of 2.00 or above at the end of the semester/term will return to Eligible status.

Academic Probation

- Probation status occurs when a student who begins a semester/term on Academic Warning does not earn a 2.00 or higher cumulative GPA at the end of the semester/term;
- Students with a status of Academic Probation may enroll in courses; however, they will be required to participate in an intervention developed in partnership with each college or school and the University's [Student Success & Retention Innovation](#) program;
- Students who begin a semester/term with a status of Academic Probation and earn a cumulative GPA of 2.00 or above at the end of the semester/term will return to Eligible status.

Ineligible

- Ineligible status occurs when an undergraduate student who begins a semester/term on Academic Probation does not earn a 2.00 or higher cumulative GPA at the end of the semester/term;
- Students with a status of Ineligible may not enroll in courses; however, they may submit an appeal (usually for extenuating circumstances) requesting an additional semester/term of Academic Probation status;
- If an appeal is granted, a student may enroll in courses but must complete requirements stipulated in the appeal decision, such as taking fewer units, using specific campus resources, and/or creating an academic action plan.

These five academic statuses determine eligibility to enroll in courses at the University; however, they do not determine eligibility to enroll in specific programs, schools, or colleges. Students who are not in Eligible status who earn grades in winter or summer term or have revisions to their academic record that updates their cumulative GPA to 2.00 or higher will return to Eligible status.

Standards for specific programs, schools, and colleges are determined by each program, school, or college. After the second enrolled term, programs, schools, and colleges may require a program change (RPC), if sufficient academic progress has not been made in the current major. Students with a Major Change will work with their school or college to determine a new academic program within their college. Students with a Required Program Change will be directed to the [A Center](#) where academic advisors help students select courses, consider alternative degree programs (majors), or discuss the appeal process.

An undergraduate student's eligibility to enroll in courses does not ensure [satisfactory academic progress](#) for financial aid purposes. Students who receive financial aid should consult directly with the [Office of Scholarships & Financial Aid](#).
