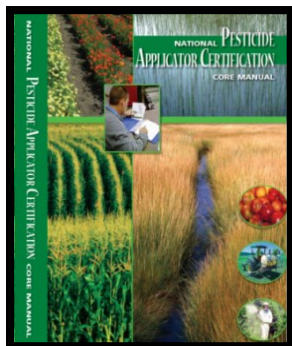
ACCESSING STUDY MATERIALS
