

## **Instructions for Registration Forms**

Please fill in your name, mailing address, and daytime phone numbers. There are two tabs at the bottom one is for dry material and one is for liquid. Please use the correct tabs. Please fill in as much information as you can. When the form is complete, please mail it to smerle@azda.gov.

### **(1) Pesticide Name**

If the information cannot be obtained please write in UK for unknown.

If you are uncertain what the unusable pesticide is, but think it is a certain product, please note what you think it is. Your best guess is better than ours.

### **(2) Registration Number**

If the information cannot be obtained please write in UK for unknown. If you even have a partial number, please write it in.

### **(3) Container Size**

Write in the approximate container size.

### **(4) Number of Containers**

Write in the number of these containers.

### **(5) Approximate Amount**

Please write in the how much of the material you estimate is in the container(s) – the size of the container and amount in the container can be different.

### **(6) Unit of Measure**

For dry materials write in the number of pounds. For liquids write in the number of gallons.

Examples: Dry - 50 #, 25 #, 10 #, 5 #, 1 #, .5 #, .25#

Liquid - 55 G, 30 G, 2.5 G, 1 G. .25 G (same as a quart),

### **(7) Over-pack needed**

Please check this box if you feel the container(s) is in such poor shape as some sort of over-pack will be needed. We will provide large clear plastic bags for containers which you mark as needing over-packing. If the container will not fit into the plastic bag (~30 G or larger), you will need to find an over-pack drum. If you have several containers of the same product, please indicate how many of the containers will need over-packing, in the additional information column.

### **(8) Comments**

This is the area you can put the color of the product, how many containers are in bad shape IE 3 of 5 need over-packing, or whatever you think will help to prepare the contractor for collection. If it is an unknown pesticide, the approximate age of the material would be very useful. You can use more than one line for registering a single item. When the form is complete, please mail it to smerle@azda.gov.

We cannot accept mini-bulk containers. We can however, accept the material from in the container if you can get it into a service container. If you have a fumigant, we will need to visit to see what options we have for disposal with the contractor. This is why the daytime phone number is critical, so we can talk before any decisions are made. If you have any questions please feel to call Jack at 602-542-3575.

## **Unusable Pesticide Disposal Information**

### **What this is**

This is a collection program for the collection of pesticides that require disposal due to age, contamination, cancellation or they are just no longer useable to you.

### **What this isn't**

This is not a program for the collection of household hazardous waste, empty containers, adjuvants or other products that are not pesticides, such as paint and used oil. If you bring it, you will leave with it.

### **Registration and getting Others Involved**

We will be going out to all our pesticide related licensees through email blasts. Feel free to share it with others who may have unusable pesticides. Anytime these events are held, they are open to anyone, who has unusable pesticides for disposal – whether on Indian Lands or off.

### **Is this going to get me into trouble?**

No, this helps you to stay out of trouble by allowing a safe, verifiable and inexpensive way to dispose of your unwanted pesticides.

### **Cost**

This program is free to participants. You will need to get the pesticides that need disposal to the collection event location.

### **What if I cannot make it to the collection?**

Participants may work together to transport the unusable pesticides to the collection site. The person delivering to the collection site will need to have the forms provided for all the accepted participants for whom they are delivering.

### **What if I find more pesticides after I have registered?**

Notify the department immediately so we can check with the contractor to see if there is any way the additional unusable pesticides can be accepted or not.

### **Are there pesticides that are problematic for acceptance into the program?**

Yes. 1) Pesticides which contain dioxin such as 2,4,5-T, Silvex, Dinoseb, pentachlorophenol. It is yet unknown if we are going to be able to find a way of disposing of these materials. 2) Large pressurized containers can be problematic as well. Please include as much information as possible. They need to have the valve protective cover in place. We need to know if the valve works. Photos are helpful.

### **How will the program work?**

1. Through this registration process, we are determining the amount and types of pesticides that need to be gathered and disposed. This will take a couple of months.
2. We will submit the bulk amount listing of materials to contractors who will then bid. This will take a couple months.
3. Upon receiving the proposal, we will approve one and then determine if there are any limitations on the amount of material that will be accepted and the number of participants.
4. We will notify everyone of their acceptance or of our inability to collect their waste pesticides. (Plastic bags will be sent out as requested for over packing.)
5. Those accepted will be notified of the collection location, the date, how to safely transport the unusable pesticides, what information must be brought to the collection and any other necessary information. We normally do a couple events each year.
