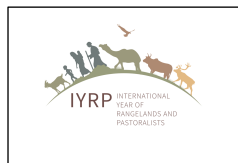

Outline:

The breakfast meeting on Sustainable Pastoralism will provide an overview and plans for a proposed International Year of Rangelands and Pastoralists (IYRP), led by the Government of Mongolia. The reasons for the call will be presented, including the results of a Gap Analysis commissioned by UN Environment, following the passing of a resolution on Combating Desertification, Land Degradation and Drought and Promoting Sustainable Pastoralism and Rangelands at UNEA2 in 2016. A proposed resolution led by the Kenyan and Ethiopian governments on rangelands and pastoralists, highlighting the need for implementation of the gap analysis and an IYRP, will be presented.

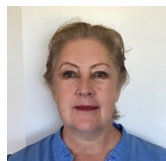
Key messages:

- Global significance of rangelands and pastoralists, and their contribution to sustainable development including present and future challenges, benefits, innovations and opportunities including in relation to provision of environmental services, and optimization of sustainable livestock production for strengthening pastoralist livelihoods and national economies.
- The importance of an International Year of Rangelands and Pastoralists (IYRP) for Mongolia and globally.
- The significant gaps in data on rangelands, and recommendations for filling these.
- The need for commitment from governments and the UN to addressing the challenges facing rangelands and pastoralists including gaps in data, and drawing attention to these.

Shirley is Assistant Director General at the International Livestock Research Institute (ILRI) based in Nairobi, Kenya with responsibilities spanning strategy, planning, partnerships, communications and knowledge management. 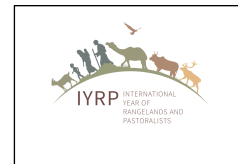
ABDELKADER BENSADA, UN ENVIRONMENT

Member of the Advisory Board of the Mongolian National Federation of Pasture User Groups of Herders (NFPUG). The NFPUG was established in 2015 and today consists of j70 000 herder households as 1440 Pasture user groups. Rangeland use agreement are established between pasture user groups of herders and local government to ensure protection of their traditional user rights. The Rangeland use agreement is the key concept of a new rangeland law prepared and ready to be submitted to the Parliament.
