Under the guidance of a scholarships process review completed by Division Business Services, my office will begin a review of all CALS UA Foundation endowments. The goal is to identify any scholarship-related accounts that are not currently listed on Scholarship Universe. All scholarships currently listed on Scholarship Universe will remain there and managed by CAS. This new review will only apply to scholarship or student support-related endowments that are not currently on Scholarship Universe and managed by my office.

If we find such endowments, you will have a choice as to how they are to be managed going forward. Please reference the attached PDF for a full description of the process we will follow. In short, Camille Andersen may contact you in the next few months to discuss any endowments that she discovered during our review. If Camille contacts you regarding an endowment, she will provide details on the account information and past spending. As a preview, your two options after the review are included below. *No action or decisions are needed from you unless we reach out*.

If you opt for Career and Academic Services to manage this endowment:

- The endowment income will be used in full to fund student scholarships based on the endowment agreement's eligibility requirements. The endowment will be listed on Scholarship Universe.
- Career and Academic Services will manage the entire scholarship process of the endowment (see below), including awarding and funds transfers from the UA Foundation.
- Your department's scholarship committee will select winners based on eligible applicants.

If you opt to manage this endowment internally in your own department:

- You acknowledge that you and your department will follow all fiduciary compliance requirements associated with this endowment. You will utilize the funds according to the requirements in the legally signed endowment agreement. All queries about the management of the endowment's funds will be forwarded to your department.
- The endowment will not be listed on Scholarship Universe. If you opt to use the funds for student scholarships, your department is responsible for the entire process:

- o Setting up any corresponding KFS and financial aid item types (if applicable),
- O Advertising the scholarship,
- o Compiling applications,
- o Selecting winners,
- o Collecting student thank you letters to the donors and sharing these documents with CALS Alumni and Development,
- o Awarding the winners on UAccess Student,
- o Transferring funds from the UA Foundation (if applicable) to cover disbursed scholarship awards.
- Even if this endowment is managed in-house, you are expected to use the full amount of funds available per year. This is in line with all other student support-related scholarships in CALS.

This marks the final stage of our year-long process of bringing CALS scholarships into compliance with Foundation guidelines and endowment agreements.
